

COVID-19 SAFETY PLAN

Lip Smacking Foodie Tours operation does not solely operate with just guests and tour guides. All of our outside partners, service providers, and vendors are also responsible for operating and adhering to public safety efforts. We are fully committed to respecting all rules, recommendations and requirements of experts and government officials. We are closely monitoring government policy changes, Centers for Disease Control (CDC) guidelines, government mandates, and public health advancements, and we will continue to make changes as necessary or appropriate to our protocols and procedures. Our guests, tour guides and restaurant partner's health, safety and well-being are our number one priority at Lip Smacking Foodie Tours. With that in mind we have outlined below the efforts in which we have focused our attention to increase and secure guest safety.

- Lip Smacking Tour guides are tested for COVID-19 each month. In addition, each guide must self-diagnosis before each tour and report any irregular temperature and/or symptoms.
- Tour guides and restaurant staff are required to wear a face covering at all times and personal protective equipment will be worn by staff based on their role and responsibilities and in adherence to state or local regulations and guidance.
- Guests participating in eating or drinking are required to wear a face covering until seated inside each restaurant.
- Tour guides ensure that all guests have access to complimentary hand sanitizer and face coverings and guest may be subject to temperature checks prior to entering resorts and restaurants where our tours operate.
- Tour guides receive training on health and hygiene principles modified in accord with recommendations and requirements from the Southern Nevada Health District.
- Tour guides are reminded not to touch their faces, wash their hands frequently, and practice physical distancing by standing at least 6 feet away from guests and others whenever possible.



- Tour guides who exhibit no symptoms but know they have been exposed to COVID-19 outside of work will be placed on a 14-day temporary leave to self-quarantine and produce a negative COVID-19 test result before returning to work.
- Tour guides are required to stay home if showing COVID-19 symptoms and inform management they are showing symptoms. Tour guides must produce a negative COVID-19 test result before returning to work.
- Guests are instructed to immediately notify their tour guide if they are feeling ill or have recently. Steps will be taken to ensure all guest safety.
- When tour guides interact with guests, they avoid physical contact with guests, exercise maximum space between themselves and guest while still enabling proper communication.
- Guests will be advised to practice physical distancing by standing at least 6 feet away from other groups of people not traveling with them and when moving throughout the tour.
- Tables at each restaurant are arranged in accordance with the state of Nevada Executive order on reopening food services venues. No table seats more than 6 guests and all seating arrangements have a minimum of 6 feet in between each table. Each restaurant is limited to 50% of their capacity.
- Menus are single use and disposed promptly after use.
